





## PROPOSAL

## PUBLIC POLICY PILOT PROJECT (PPPP) ASSUMPTIONS

1. There are branches and members interested in public policy.
2. The task of monitoring public policy must be easy for a branch/member to manage.
3. Focusing on a few specific pieces of legislation - rather than the entire gambit of women's issues - is "doable" for most branches/members..

## PUBLIC POLICY PILOT PROJECT (PPPP) ASSUMPTIONS

4. Participating branches will probably choose one legislative issue which reflects the interests and/or expertise of their members.
5. Participating branches/members will need tools as well as a clear set of expectations to participate in the PPPP.
6. Implementing a PPPP will be governed by the time frames of the sessions at the state level (long and short sessions in Raleigh) and at the federal level (short breaks)

# AAUW NC Public Policy

## THE 'PLAYERS' IN PUBLIC POLICY PILOT PROJECT (PPPP) – 1 OF 3

### BRANCH PRESIDENTS

- advocate for the project to be adopted in their branch
- officially commit the branch to being part of PPPP by selecting an issue for which they would commit to monitoring
- recruit branch members who would like to be involved in PPPP

## THE 'PLAYERS' IN PUBLIC POLICY PILOT PROJECT (PPPP) – 2 OF 3

### MONITORS

- branch members who would take responsibility for monitoring/overseeing their issue
- branch members who would take responsibility for alerting AAUW NC members who were committed to taking action on legislative action that impacted girls and women
- branches would identify SENDERS

### ACTION "PLAYERS"

- branches would identify branch members who were committed to taking action on issues impacting girls and women
- Branches would identify RECEIVERS

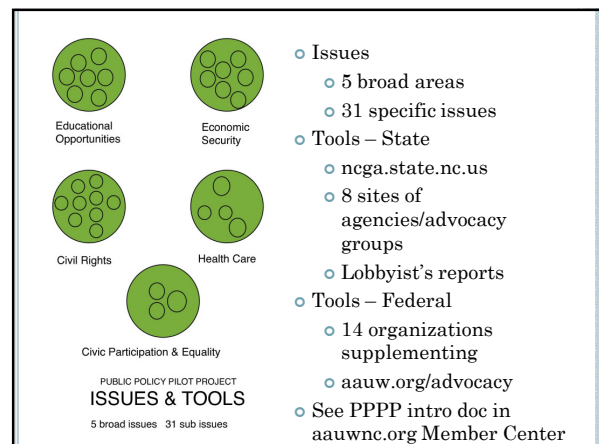
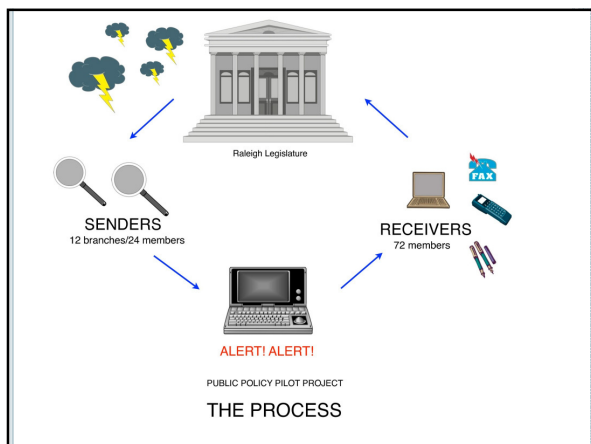

## PPPP EVALUATION AND OBSERVATIONS

### INTRODUCTION OF THE PROJECT TO BRANCHES/FALL 2011

- Good representation of the branches
- Good discussion on the merits of project
- Good set of complementary materials to introduce the project (roles, assumptions, timelines, etc.)
- Good response from those branches present

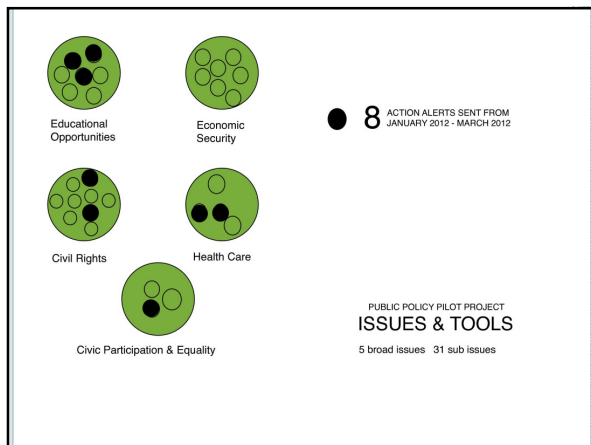
## PPPP EVALUATION AND OBSERVATIONS

### FEEDBACK FROM BRANCH PRESIDENTS AT ANNUAL MEETING IN BURLINGTON 2012

- branches have more ownership now in AAUW through PPPP
- AAUW NC is more focused and less distracted on state business
- communication between the branches and AAUW NC has improved
- branches feel more connected to each other through PPPP
- branches participating in PPPP now have a small group focus on a project

## PPPP EVALUATION AND OBSERVATIONS/OUTCOMES

- a majority of branches (12) agreed to participate in PPPP
- all major issue areas were covered in the branch selections
- four major issue areas had at least one alert (education funding, violence against women (2), voting, access to reproductive health care (2), bullying, education privatization)
- Some branches are more practiced than others in monitoring and taking action on public policy issues

## PPPP EVALUATION AND OBSERVATIONS/OUTCOMES

- Difficulty translating information from the area meetings to the branch level/confusion in some of the roles
- Lack of attention to materials/samples to use alerts to receivers
- Overreach on the number of issues to be addressed
- Perhaps an overload of resources for senders to monitor
- Lack of immediate follow-up with branches

## WHAT'S NEW FOR 2013?

- Long session of the NC General Assembly
  - Much more activity, some starting next week
- NC NOW lobbyist is changing
  - They want to involve AAUW members
  - They will have "boots on the ground" on Jones St.
- AAUW is providing CQ StateTrack
  - Automated search of NCGA website for legislative changes
  - Available by email and for posting on web site(s)
  - Tool for our use, and helpful to our allies

- CQ – Congressional Quarterly
  - System similar to one that is in use at federal level
  - Provided to all states as an AAUW member benefit
- Will start when Legislature convenes on Jan. 30
- [List of bills from 2011-2012 session](#)
  - 332 bills related to keywords defined by AAUW
  - Info on 5 of 10 priorities on our 2011 list
  - AAUW NC may update list of keywords
- Samples of reports from other states

## SAMPLE FROM ILLINOIS

- Number: **IL HB 5825** - Updated (Status 12/07/2012)
- Sponsor: Linda Chapa LaVia
- Title: [SCH CD-HOME HOSPITAL GRANTS](#)
- Abstract: Amends the School Code to provide that, except for those children qualifying under the Article of the Code concerning children with disabilities, school districts shall be eligible to receive reimbursement for all children requiring home or hospital instruction at not more than \$1,000 annually per child or \$9,000 (instead of \$8,000) per teacher, whichever is less.
- Status: [House Sent to the Governor - 12/06/2012](#)

- Title: [Comm. Colleges/Opt Out of Fed'l Loan Prog-2](#)
- Abstract: AN ACT To provide that certain North Carolina community colleges may Opt Out of participation in the William D. Ford Federal Direct Loan Program.
- Status: Ch. SL 2011-178 - 06/18/2011

## NO SILVER BULLET

- CQ StateTrack is a tool, not a solution
- Reports will need careful, informed review
  - All tools from 2012 will still apply
- Second phase of project will include "write your legislator" functionality
  - Expect to see that in the next fiscal year for 2014 session
  - Would change our pp-alerts and add tracking on how many members actually take action.
  - What do we need to do in 2013 to be ready for that?

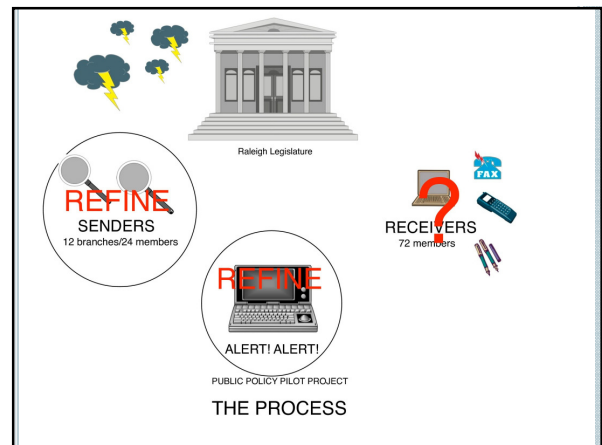

## RECOMMENDATIONS: TIGHTEN THE PROCESS

- Reduce the number of issues that are monitored
  - 33 was too many
- Strengthen the day-to-day leadership of the program
  - Designate a \*few\* people responsible for ensuring the program is meeting its goals
  - Call this the "PP leadership team"

## WHAT CHANGES ON OUR TWO E-MAIL LISTS

- pp-info - general information on many issues
  - Will get email from new CQ StateTrack system
  - May receive some notices from branch PP chairs
  - Any member may subscribe without requirement to be a "sender" if they want to get all information.
- pp-alerts - specific information needed to contact legislators on priority issues
  - Messages will be brief and to the point
  - Leadership team will be responsible for deciding who posts on what
