# GENERAL ASSEMBLY VOTING RECORD

## 2013 Regular Session

**January 9, 2013\*; January 30, 2013 – July 26, 2013**

Members of the American Association of University Women of North Carolina (AAUW of North Carolina) have a history of lobbying their state legislators, both at home and in Raleigh, and holding their legislators accountable for how they vote on AAUW of North Carolina issues. This voting record provides information about elected state legislators through the votes they cast on critical AAUW issues.

## ***INTRODUCTION***

Members of the American Association of University Women of North Carolina (AAUW of North Carolina) have a history of lobbying their state legislators, both at home and in Raleigh, and holding their legislators accountable for how they vote on AAUW of North Carolina issues. This voting record provides information about elected state legislators through the votes cast on critical AAUW issues.

This voting record covers the 2013 Long Session of the General Assembly (January to June 26, 2013). We based our selection on the input from the regional fall meetings and on bills opposed or supported with our ongoing advocacy during the session. All of AAUW of North Carolina's advocacy efforts conform with the national AAUW Public Policy Program, whose principles and priorities are developed and approved by members on a biennial cycle.

The voting record lists roll-call votes officially recorded on the floor of the Senate or the House. The voting record is neither an endorsement nor a condemnation of any member of the North Carolina General Assembly. ## ***READING THE VOTING RECORD***

A recorded "yes" vote indicates that the legislator voted for the bill.

A recorded "no" vote indicates that the legislator voted against the bill.

EA is excused absence; NV is no vote.

The % score is the number of no votes divided by the total number of votes.

Sponsorship of a bill is indicated by a PLUS or MINUS. A PLUS indicates a sponsor of a bill we favored and a MINUS a sponsor of a bill we opposed.

## ***USING THE VOTING RECORD***

AAUW members and other concerned citizens can use the voting record to hold senators and representatives accountable for their positions on AAUW's Priority issues in a variety of ways:

- Refer to the information in the voting record during community issue forums, candidate debates, or at town hall meetings held by the legislator.
- Use the voting record when writing letters to the editor, blog posts, or Op-Eds about a legislator's position and AAUW's issues.
- Share the record with coalition partners, friends, family and prospective members.
- Distribute copies at voter education events and at local libraries and civic centers.

***DESCRIPTION OF BILLS THAT WERE ENACTED INTO LAW*****Senate Bill 4 / S.L. 2013-5 (= H16) No N.C. Exchange/No Medicaid Expansion.**

This bill had three main components and they were:

- (1) The state would not operate a state-run or "partnership" health benefit exchange
- (2) It provided that future Medicaid eligibility determinations will be made by the state rather than the federally facilitated exchange
- (3) The state rejected the Affordable Care Act's (ACA) optional Medicaid expansion

AAUW NC *opposed* this bill as many North Carolinians would have benefitted from the Medicaid expansion offered by the ACA and many citizens would have had lower premiums if we had a state-run partnership health benefit exchange. We felt this would have helped many of the uninsured citizens of our state.

**House Bill 4 / S.L. 2013-2 (= S6) UI Fund Solvency & Program Changes**

This bill cut both the length of time an unemployed person could receive benefits and the maximum amount of money the unemployed person was eligible to receive.

AAUW NC *opposed* this bill as NC had a higher than average unemployment rate. Because the number of the unemployed citizens in our state was greater than the available number of jobs, it did not mean that people were not seeking employment. As a result many families and especially children suffered to a greater degree than if they had not had benefits cut.

**Senate Bill 337 / S.L. 2013-355 NC Charter School Advisory Board.**

This bill provides for a 10 member appointed board plus the Lt. Governor and the State Superintendent of Instruction (non voting member) to advise the State Board of Education about any and all charter school operation and make recommendations regarding applications for new charter schools.

AAUW NC *opposed* this bill for two reasons. First we feel public school funds should not be diverted to schools that do not have the same requirements and standards as public schools. Secondly, we feel this is an unnecessary Board and is using state money that could be better used by the State Board of Education.

**Senate Bill 353 / S.L. 2013-366 Health and Safety Law Changes.**

This bill is a package of controversial abortion restrictions that threatens to severely limit reproductive access by shutting down clinics. SB 353 authorizes regulations making abortion clinics meet the same standards as surgical centers. In addition, SB 353 also allows health providers to deny their patients abortion

care based on their own religious beliefs and prevents government-run health insurance plans from covering abortion services.

AAUW NC *opposed* this bill as we feel women should be free to make their own decisions regarding their bodies. Also we know that the Planned Parenthood clinics are the only form of health care for some women of limited economic means. To deny healthcare such as mammograms and pap smears for all women and girls is unthinkable.

### **Senate Bill 402 / S.L. 2013-360 Appropriations Act of 2013.**

This was the budget bill and it contained many education cuts which AAUW NC *opposed*. AAUW NC believes in a strong system of public education to ensure each child in NC a basic education. The following is a list of the bill's impact on public education funding:

- Cuts overall funding when you adjust for inflation and growth in student population.
- A voucher program (Opportunity Scholarships) will begin the diversion of tax dollars (\$10M initially) from public to private schools.  
NOTE: This provision is presently to be decided by a lawsuit in the NC court system.
- Teacher assistants cut by \$120M (3,800 positions)
- Teacher tenure eliminated
- Teacher pay frozen
- Incentive pay for teachers with advanced degrees eliminated
- Change to students to teacher funding ratios will likely force local school districts to increase class size.
- Successful NC Teaching Fellows Program will cease; instead, \$11M will be allocated to Teach for America.
- Cuts funding for instructional supplies
- Cuts the allotment for Limited English Proficiency students by \$6M
- Funding for the NC Center for Teaching Advancement (teacher professional development) are now non-recurring.

### **House Bill 589 / S.L. 2013-381 VIVA/Election Reform**

#### **Changes for 2014 elections**

- Early voting: one week less
- Mail-in voting: ID# needed
- No same-day registration
- No straight-party voting

#### **In 2016 you will need to show photo ID to vote**

AAUW NC *opposed* this bill as it will make it more difficult for the elderly, minorities, and the low income population to vote. This bill has lawsuits filed against it in both the federal and the state court system.

### ***ADDITIONAL BILLS CONSIDERED IN THE VOTING RECORD***

Two additional bills are considered important enough to be included here even though there was no roll call vote. The voting record indicates sponsors of HB 944 with "MINUS", and sponsors of HB 603 with "PLUS".

#### **House Bill 944 Opportunity Scholarship Act.**

This was referred to the Appropriations Committee and was included in the **Appropriations Act of 2013 SB 402**. This is really a bill creating a voucher program, diverting millions of taxpayer dollars from public schools to unaccountable private schools.

AAUW opposes vouchers for the following reasons:

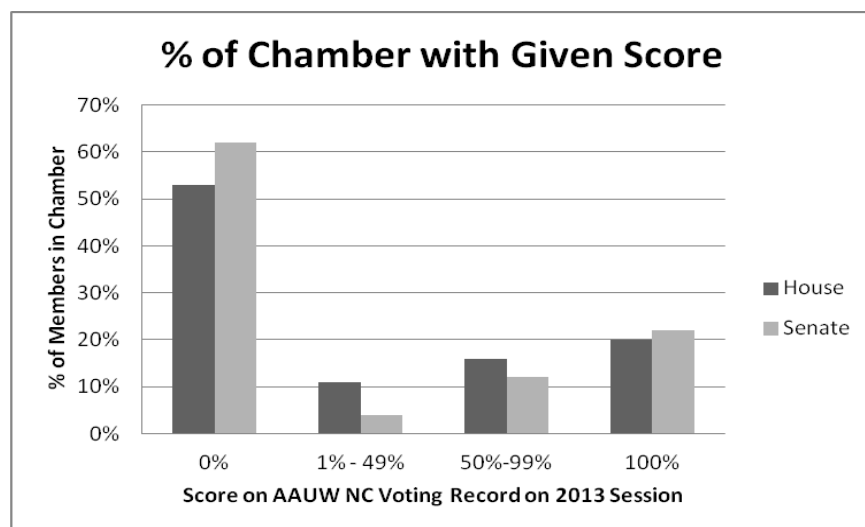
- It violates the NC constitution
- Private schools are unaccountable for public funding
- Vouchers drain funding from underfunded public schools
- Vouchers programs have not shown to improve student achievement e.g. Milwaukee and Cleveland programs.

#### **House Bill 603 Equal Pay Act**

This bill was introduced and after the the first reading, it was sent to the Rules Committee where it died. We listed the sponsors of this bill. No vote was taken on the bill. AAUW NC supported this bill. Equal pay for equal work should be a standard in this state and in our country. It is one successful way to help eliminate poverty for women and children as many single parent households are headed by a woman.
