SAVE THE DATE - NOVEMBER 1 IS OUR ANNUAL “LUNCH WITH CAROLINA AUTHORS”.



Presenting authors are:

Those of us who have been around this branch for awhile like to sling acronyms around, such as , “LAF”. What is this, some kind of secret language? Let’s see, does it stand for “Local Academic Females”? No? How about “Lady’s Advancement Fraternity”? Getting warmer! How about “Legal Advocacy Fund”? Hey, that’s it, we’ve hit the bull’s-eye!

With that mystery solved lets go on to the next.

Question: What is the Legal Advocacy Fund?



Answer: It’s a way to help women in the workplace or in academia who have suffered from hitting their heads against the glass ceiling, or in other word been the victims of gender discrimination. This could entail harassment, salary inequity, or unjust promotion and tenure practices, among other gender injustices. If, after trying to right the wrong through normal channels, the case ends up in court, AAUW uses its resources and legal know-how as “Friend of the Court” to aid in attaining a just settlement for the plaintiff.

We as branch members do our part by financially supporting the AAUW fund that makes this legal work possible.

We have, during the past 25 years, provided funds directly to the plaintiff for legal expenses. This practice is being phased out, as the organization switches to a broader approach. We will however continue to provide funds for those cases where we have already made a commitment.

Our branch has held up its corner of the LAF blanket well. We hope to do so again this year.

FINANCIAL ISSUES FOR WOMEN - WHAT ARE YOUR CONCERNS?

September was "Life Insurance Awareness Month". I have attached to this Newsletter a form that may be helpful now that you have investigated your insurance products. I will continue to offer a free review of the insurance products to AAUW members and their families. It is very important to have a review periodically to see if your goals and needs have changed. In addition, I have found when reviewing insurance beneficiaries that many are outdated leaving blank the contingent beneficiary. If you have a broker working with you, please use his/her services for the above purpose or call me.

As you review your insurance protection, remember to see what protection you and your family have if someone has a stroke, an accident and is temporarily or permanently disabled. Many of us have children who haven't taken this into consideration and perhaps you will be asked to participate in their recovery whether it be financially or personally. As parents, we are always there for our children in good times and in bad. However, with proper planning, our children can remain independent.

As we age, more and more of our friends and family experience health issues. This happened recently to very dear friends. With one friend, there was a need to be a "third ear" since her age and her experience with financial issues were limited and her family was a distance away. I was very happy to be of help but, it was really a learning experience for me as well. Here are some things I learned:

- Even though we think we understand coverage, we really don't.
- When we reach the age of 65 we are offered Medicare from the US government. However, many people who feel the premium is too high elect to purchase a Medicare Supplement. In some cases, the supplement waives out the Medicare coverage. This means that Medicare will not be the primary payer for the claims you have. The supplement policy takes over as first payer.
- In the current experience I learned that my friend's policy covered 100% for the first three days in a nursing facility for rehabilitation. Days four to thirty eight (38), my friend had to pay a certain amount for example \$100 per day, which comes to \$3,800. She has already paid hospital fees that will be counted toward her maximum "out of pocket" (what she pays) of \$3000.
- Days 39 to 100 the policy will pay 100% and once the maximum out of pocket gets to \$3,000 on her policy, 100% is covered.
- After day 100, my friend will have to pay for her spouse's care and rehabilitation. She may have to move to be near her children since she may not be able to assist in his rehabilitation. If she needs federal financial assistance she can apply for Medicaid. As you all know to get Medicaid, you have to be indigent. There are many rules and procedures to follow when applying for this aid and whatever is given to the recipient, usually has to be paid back.
- On the other hand, if you have Medicare, the first 20 days is paid for in total. For the next 21 to 100 days, there is a daily rate of \$128 to be paid by you. After that time, you would be responsible for payments unless you were approved by Medicaid. The site www.medicare.gov can be very helpful.
- According to Mutual of Omaha, 61% of the 2.1 million Medicaid applications are denied, but there is a process of appeals to help those in need.

Join me next month as I explore the various types of insurance and perhaps you will become more familiar with its valuable service and share it with other family members and friends. Until then, remember the old saying - "WE DON'T PLAN TO FAIL, WE JUST FAIL TO PLAN"..... Don't let that apply to you.


