Meeting Opening Pat Ashe, President	The meeting was called to order at 5:33pm by Pat Ashe. The agenda is posted in APPENDIX A.
Minutes from the Last Meeting Adrienne Stuckey, Secretary	The minutes from the April 20, 2022 and June 25, 2022 meetings were provided to the Board members by email for review prior to the meeting.

	Board members did not recommend any changes, so the minutes were accepted as presented.
Treasurer's Report Paula Munger, Treasurer	The financial report as reported by Paula Munger is posted in APPENDIX C. Mary Ann Bents recommended updating the TechTriad

	payee name with Get You Found, the new company. Mary Ann Bents also reported that the disbursement reports will be sent by AAUW National starting on the 3rd week of the month (this is a change in schedule).
Executive Committee Pat Ashe, President	Jane Terwillegar has reported she will be stepping down from the board. We appreciate her seven years of service to the State Board! The nominating committee for next March's Business Meeting will be appointed for approval by the board as soon as possible. The positions for election are President and Branch Advocate. One committee chair recommendation is Cynthia Raymond (Cape Fear and Tarheel branches), and Pat Ashe will reach out to her to determine if she is willing to be appointed. On August 24, the Executive Committee will meet with the Branch Presidents and Treasurers, so Pat will ask for recommendations for committee members there. Beverly has volunteered to be the Membership Chair for this year.
Public Policy <i>Katie Pincura, Public Policy</i> <i>Chair</i>	Policy areas of focus for 2023 will be Education (Leandro case mandated fair funding in NC), Healthcare (Medicaid expansion efforts in NC), and Reproductive Choice (upcoming elections). Dr. Pincura provided several potential activities for each focus area.
STEM Christi Whitworth, STEM Chair	Fall STEM activities are being scheduled and will be reported at the next meeting.
Diversity, Excellence, and Inclusion (DEI) <i>Tiffany Jacobs, DEI Chair</i>	Pat Ashe reported in Tiffany Jacobs' place. AAUW National is scheduling DEI trainings that we can sign up for soon.
Communications <i>Kathy Pearre, Communications</i> <i>Chair</i>	Kathy Pearre reported that the Communications committee is seeking additional volunteers from across AAUW NC for roles on the committee. Kathy will solicit help from board members to review the AAUW NC website for recommendations, including for using the "lead" section of the website to respond to current events. AAUW NC ZOOM account use by branches has been decreasing across the summer. The Charlotte Branch is the most active Branch using the account.
<i>Connect</i> Newsletter and Guidelines & Procedures Manual	Connect <i>Newsletter:</i> A special June edition was sent out, and the open rate was 44.2%. In July, there was no issue published. The August

Guidelines and Procedures Manual Mary Ann Bents, Nicole Sherrill-Jamison	 Mary Ann Bents reviewed a document summarizing updates and organizational structure of the updated Guidelines and Procedures Manual. The summary is posted in APPENDIX D. A huge thank you to Mary Ann Bents for leading this year- long process and to Dr. Nicole Sherill-Jamison for providing extra support.
Other Business Pat Ashe	 AAUW NC Strategic Goals 2022-2023 Approval of Goals for 2022-2023. Proposed goals are posted in APPENDIX B. Kathy Pearre asked whether the current goal of 706 membership by February 1, 2023 is appropriate. Pat Ashe responded that the goal of maintaining current membership (706) seemed wise in light of COVID impacts. After some discussion, the Board decided to revise the goal <i>1a. Achieve membership levels of 706 by February 1, 2023</i> with a goal for assisting Branches with the transition to Community Hub (see also below under <i>Branch Presidents & Treasurers Meeting</i>). Mary Ann Bents recommended a goal to support branches in keeping their websites updated with all areas of contact information and social media channels. This will require an inventory of current branches. Kathy Pearre asked if any Branches have indicated intent to discontinue; Pat Ashe reported none have done so. Pat Ashe reported that AAUW NC have been awarded 4-Star Rating. Charlotte has also been awarded 4-Star Rating. Charlotte has also been awarded a star, but no response has been yet given. All of these achievements will be announced in the next issue of <i>CONNECT</i>. Kathy Pearre recommended that the Board accept the <i>AAUW NC Strategic Plan Goals 2022-2023</i> with the recommended revisions listed above. Adrienne Stuckey seconded, and the verbal vote to approve was unanimous.
	Branch Presidents & Treasurers Meeting August 24, the Executive Committee will meet with the Branch Presidents and Treasurers to discuss and problem- solve membership record issues. Mary Ann Bents has

	been attending scheduled tech support office hours supporting the AAUW National Community Hub on behalf of Branches. Community Hub is the membership information portal available to certain state board members. Pat Ashe is working to expand the Board Members who can access Community Hub to help track membership across the state. Janet Bunger recommends providing Branch leaders with identity and purpose information/materials about AAUW to support new member recruitment. We recommend branches send names and emails for new members to the Connect editor, Mary Ann Bents, so that they can be added to the Connect newsletter mailing list. Obtaining new member information from the Community Hub may be a challenge until this service is more stable.

Policy Chair Report

AAUW-NC 2022-2023 POLICY ADVOCACY UPDATE

Katie Pincura, AAUW-WCU branch AAU

2023 Policy Areas of Focus

- Education
 - Leandro case: fair funding for NC public education. State has not been providing equal education to NC schoolchildren.
 - The state SC will address this on August 31 a judge has ordered that the Leandro plan be fully funded, but the NC Court of Appeals blocked this, arguing that only the GA has the power to make this call.
- Healthcare
- NC still has not expanded Medicaid
- Hospital groups are reportedly blocking bipartisan efforts
- May be taken up by GA this year
- Reproductive Choice
 - Upcoming elections will be the most critical factor in determining the future of reproductive choice in NC

2022-2023 Advocacy Goals: Education

- Education area of focus: Leandro
 - Continue to support Every Child NC coalition
 - Ask local leaders to pass resolutions in support of Leandro funding
 - Raise awareness: write letters to editors, attend rallies/events, etc.
 - Use the Every Child NC impact analysis tool to learn more about how different communities would be affected by full funding <u>https://everychildnc.org/leandro-impact-analysis-early-education/</u>

2022-2023 Advocacy Goals: Healthcare

- Healthcare area of focus: Medicaid expansion
 - Ask local leaders to pass resolutions in support of Medicaid expansion
 - Letters to editors, op-eds, rallies/events, etc.
 - Meeting with representatives to discuss
 - Join state healthcare coalition(s)

2022-2023 Advocacy Goals: Reproductive Choice

- Reproductive choice area of focus: get out the vote
 - Hold nonpartisan GOTV drives (Twin Rivers has scheduled dates, WCU is planning GOTV drive)
 - Work with existing coalition to amplify efforts (Planned Parenthood, NC Choice, Sister Song, ACLU, Charlotte for Choice)
