Subject	Discussion/Progress/Decisions							
Meeting Opening Pat Ashe, President	Pat Ashe, President, called the meeting to order at 5:35. She asked our guest, Catherine Magid, to introduce herself. Catherine is a member of the Greensboro branch and states she is very interested in Public Policy. Pat asked if she would consider being the state Public Policy Chair and she stated that she would very much like that. Pat appointed her the new Public Policy Chair with the concurrence of the board. Pat will follow up with Catherine to discuss the role and determine with her next steps.							
Minutes from the Last Meeting <i>Elizabeth Pou, Secretary</i>	The minutes from the November 20, 2024 meeting were provided to the Board members by email for review prior to the meeting. Correction of Millie's name requested. Minutes accepted as distributed with this minor change.							
Executive Committee Pat Ashe, President	No meeting							

Public Policy Pat Ashe, Interim Chair	Congratulations to Catherine Magid in her role as new PP Chair. Pat reported that there was sparse attendance at the PP meeting held on December 3, 2024. There was good discussion with Meghan Kissell, AAUW Senior Director for Policy and Membership Advocacy. She indicated we would likely see changes in Title IX, especially related to LGBTQ+; many changes in public education, e.g. vouchers, removal of Pell Grant from 2 & 4 year schools, and a move to more workforce development; and the continuing need to pass the Paycheck Fairness bill that's in Congress. The proposed biannual AAUW Public Policy Priorities are currently out for comment and will be voted on this spring. Laura reported that she commented that they were more narrow and less inclusive than current ones.
Treasurer's Report <i>Millie Hoffler-Foushee,</i> <i>Treasurer</i>	Millie gave a report on the issues surrounding our Pay Pal Account. She indicated that the issues have been resolved and substantiation that the account is working with the help of Mary Ann. Thank you, Mary Ann, for your donation to the state as part of this verification process. The YTD budget reveals an under budget income due to fewer membership dues than anticipated and expenses running under budget. See Appendix D.
President Nomination	Pat stated that she had appointed herself as Chair of the Nominating Committee and that Vice-President Lena Murrill-Chapman agreed to be a candidate for President. Unfortunately, no candidates for Branch Advocate have been identified. Elections will be held during the Business Meeting on March 22, 2025 as part of the Annual Meeting agenda.

STEM Ed, <i>Laura Tew, STEM</i> Chair	See Appendix B. Laura asked that the goal of communicating national information to the branches be removed as there is nothing coming from national related to STEM.
Diversity, Excellence, and Inclusion (DEI) <i>Tiffany Jacobs, DEI Chair</i>	Tiffany stated that the national committee name will be likely changed, removing diversity. The committee anticipates the potential of pushback for female only fellowships. The DEI Act will be dismantled with federal employees likely being laid off from their jobs. The discussion of possible changes by the incoming Administration has been emotionally challenging and the Inclusion and Equity Committee has been struggling as there is anticipated backtracking on ground breaking work we've done. There is an upcoming webinar on January 29th at 7:00 pm on handling difficult conversations. These recurring webinars are recorded and the link will go into the newsletter. Tiffany asked that she and Catherine work together to address the many public policy issues that will come up.

AAUW Carolinas Fund Sandy Bernard, Chair	Sandy reported that giving by NC members to AAUW Funds surpassed last year's. Laura, Mary Ann and Sandy have asked several times about getting the list of Fellowships and Community Action Grants' recipients for 2024. She finally received the data and finds there are 11 NC recipients with none being science or STEM focused. Sandy stated that more work needs to be done to get candidates for Fellowships and Community Action Grants in WNC.
Membership Lena Murrill-Chapman, Chair	No report as Lena needed to leave to attend a planning meeting for the 2026 Atlantic Regional Conference.
NCCWSL Update	Pat attended an AAUW Board Liaison meeting last evening. Some state Presidents, including NC, asked for any information about NASPA (Student Affairs Administrators in Higher Education) and whether there will be a college student leadership conference this year. The board members stated they have heard nothing on this issue and advised to continue to check the website for updates.
Other Business	Pat and Kathy will be working on the agendas for the Annual Meeting and will come back to the board with a recommendation as to whether monetary door prizes will be awarded this year to encourage attendance.
